Report from Canary Wharf Retail Multifaith Chaplaincy. I was invited to join WPC in order to share ideas and best practice in retail chaplaincy, even though Canary Wharf is in the London Diocese. The past year has seen me recruit and train two volunteer ladies of the Muslim Faith. They have been very capable additions to the team and as a result we are looking at ways of paying them. We have however see the retirement of one of the longest serving volunteers Geoff Nicholson who has achieved so much in building up relationships in retail over the years. It has also been a pleasure to have several people on placement from different denominations and faiths come and spend time with us. During the Covid crisis I have been keeping in touch with retail managers and staff through email and text messages. We have also been having a reflective Christian service on Thursdays by Zoom and a small service sheet of reflection and prayers is sent out via email to approximately 80 people who have requested it from Canary Wharf, every Thursday and Sunday. # WPC CONFERENCE 2019: SUMMARY REPORT 10<sup>th</sup> – 12<sup>th</sup> June, High Leigh Conference Centre

### 'REIMAGINING BRITAIN'

## **MONDAY 10<sup>TH</sup> JUNE**

# SESSION 1: 'REIMAGINING BRITAIN: FOUNDATIONS FOR HOPE' by Justin Welby

Martin Harris, Area Dean of Harlow, introduced this session via a recorded presentation. He recalled the changes in society through history, particularly where Christians had been influential. In earlier centuries:- the end of the slave trade, factory working conditions, education and health provision. Later, post WWII, there was support for many in social care but the influences of Capitalism and Communism saw other changes and the beginnings of a turn to Individualism. Justin Welby's book looks back at history and challenges Christians to think about how Christians might influence the society of today with the various challenges that have emerged, particularly over recent years, and as a result of 'Brexit'.

Chapters having previously been assigned, there followed discussion on how those present reacted to the book and its challenges. The varying experiences of the group, particularly where a chapter was most relevant to those there, made for lively discussion. The Chapter on Immigration and Integration was discussed at length, along with Housing, 'For Those as Yet Unborn', and aspects of several other topics in the book. In general the group was not inspired to hope but a quote on page 32 had been picked up by several:-

'In post-Brexit Britain we need a more inspiring and better narrative that shapes us in a common purpose, not a sense of division and antagonism, let alone frightened isolation, both domestically and internationally. We need a narrative that speaks to the world of hope and not mere optimism, let alone simple self-interest, that enables us to play a powerful, hopeful and confident role, resisting the turn in-

wards that will leave us alone, despairing and vulnerable. A vision of this kind will promote community, be courageous and be lived out consistently, not withstanding the events that come.'

It was felt that the book did not answer the questions so much as give starting places for further thought and potential action.

### **SESSION 2: BREXIT AND URBAN AND RURAL ISSUES**

This session was lead by Lara Dose, as Chaplain to Romford Town Centre and Janet Nicholls, Diocesan Rural Adviser and Anglican Agricultural Chaplain. Both gave a summary of how Brexit was already impacting and was likely to impact the urban and rural communities.

Some businesses are already starting to move elsewhere in expectation and jobs are threatened within many communities. Uncertainty and lack of trust are predominant. There was a lack of understanding of the true situation before the vote that persists. Antagonism towards the 'rules from Brussels' played a big part in the vote.

The rural impact of Brexit will be essentially felt by exiting the Common Agricultural Policy and the end of freedom of movement for migrant labourers. There is a degree of fear that farms will be at risk, alongside criticism of the current system. There are proposals to replace lost funding.

There followed some discussion around the perceived problems and the lack of transparency/clarity and foresight with all the issues.

## **SESSION 3: INTRODUCTION TO MENTAL HEALTH FIRST AID**

Lesley Bailey, Lead Emotional, Mental Health and Wellbeing for 'InterAct' delivered an introductory session on MHFA. The scope of what 'mental health' means, its impact and some strategies for looking at stress and relieving it were covered.

The full course is more detailed and it was suggested that this might be a topic to be pursued further.

# TUESDAY 11TH JUNE

## **SESSION 4: WPC CONSTITUTION DEVELOPMENTS**

Mike Lodge, Principal Officer for Chelmsford Diocese, gave an update of where the investigations into the Constitution were going. The current document is confusing and over complicated. Terms of Reference, organisational structure, definitions, finance, training and other aspects of Workplace Chaplaincy all need to be reviewed.

Mike is to meet with the Nick Lear (President of ECCIC) and Andy Hudson (Team Leader) with a view to producing a draft for review by interested parties to feedback for final revision.

Various attendees gave their view as to some of the items that needed addressing:general awareness of the role of workplace chaplains, multi-faith inclusion, other denominations representation, encouraging new volunteers/chaplains.

## **SESSION 5: CHAPLAINCY IN CHALLENGING TIMES**

Revd Dr Fiona Stewart-Darling, Lead Chaplain Canary Wharf Multi-Faith Chaplaincy gave the keynote address on her work and the challenges presented in the current climate to all areas of chaplaincy (present on the day) including retail, universities, rural, airports, football, care homes, and caring for both staff and people in any institution so that they know they are valued and loved by God. She spoke of the challenges of a generation that uses social media to communicate and of the opportunities and privileges inherent in being alongside people and communities today. She reminded those present that this ministry is carried out *with* God, calling us to live out the Gospel on word and action, imitators of Christ. She also reminded those present to look after themselves.

The address was well received and feedback shows that a good Keynote Speaker is key to a good response. The script of the address has since been shared with the attendees.

## SESSION 6: CELEBRATING SUCCESS AND RECEIVING SUPPORT IN CHAL-LENGING TIMES

Robert Findlay introduced the session, inviting three chaplains to explain how they worked with their teams to share both joys at achievement and support for troubles.

Rob Burles (Stanstead Airport), Christiana Asinugo (Westfield Retail Centre) and Andrew Merchant (Writtle University College) talked about their own contexts, summarising some of their challenges and working practices. Robert then invited those present to give their own testimonies of the joys and challenges of chaplaincy. We heard several stories of success and people thought it nice to be appreciated. All were enjoying their work and most, nonetheless, were feeling stressed.

## **SESSION 7: AGM, COMMUNION SERVICE AND COMMISSIONING**

## **SESSION 8: FILM**

The volunteers having departed, the remaining attendees relaxed with a film 'Swimming With Men'. 'A man, suffering a mid-life crisis finds new meaning in his life as part of an all-male, middle-aged, amateur synchronised swimming team.'

### **SESSION 9: PLANNING AHEAD**

Robert Findlay led this session, which is documented separately and forms the basis of on-going Core Group Meeting discussions.

### **SUMMARY**

The feedback from the conference indicates that it was much enjoyed. The discussions on the challenges facing chaplaincy in various contexts, as a result of the uncertainty on our society, were lively and wide-ranging. On the Tuesday, (Volunteers Day) the keynote speaker was particularly praised for her inspiring address, touching on so many aspects of chaplaincy, and for being both relevant and encouraging. One volunteer, just starting out, found the day very useful to her. Several others called it a 'day well spent'. Mental Health First Aid has been identified as an area to follow up in the near future, as the impact of mental health issues is part of the current social climate.

Above all, we are charged with helping people to find hope in a society where hopelessness is common, and to walk with them in their joy and sorrows, bringing the love of Christ to their lives through our listening ears, our compassion and our service.

The ECCIC Constitution is being looked at because it needs review to reflect current practice and to potentially include chaplaincy beyond Industry and Commerce, for example Health Care Trusts. Support roles are also being looked at. Clarification across denominations is needed, regarding Principal Officers (only Mike Lodge currently) and representation at board and CTEEL meetings. Structures are being review to better understand what it means to be a chaplain in the Diocese of Chelmsford; to encourage commitment and support; to look at training; to ensure financial security; to make Workplace Chaplains more visible.
